1. This Agreement is in partial consideration for access to the aforementioned Slip Number for the 2019 Season (or such slip as may be hereinafter assigned by the Fleet Captain) subject to the prompt payment of my slip fees (separately invoiced)
2. I have read and will abide by the Darien Boat Club "Bylaws," "House and Ground Rules," and "Dockside Slip Rules and Regulations." Copies of these documents are available at the Club or at our web site: www.darienboatclub.org
3. I will sign and date this Agreement and return 1) this Agreement, 2) a copy of my 2019 Connecticut DMV Boat Registration (herein after: Registration) and 3) a copy of the coverage page(s) of my insurance policy showing **at least \$300,000.00 per person, per incident of liability coverage** (herein after: Insurance) to the address below to be received before 5:00 PM, May 1, 2019. I will make sure my name and address is present on the Insurance documents or hand-write them in the margin.
4. I agree to maintain the coverage levels shown in my Insurance Documents for the entire 2019 boating season.
5. If I fail to return this agreement, my Registration or my Insurance to the address below by the deadline of 5:00 PM May 1, 2019, I agree to pay a fine of one half my slip fees. If I further fail to return this agreement, my Registration, my Insurance or the fine to the address below by 5:00 PM on May 15, 2019, I agree to forfeit my slip and be off the slip waiting list for a period of 3 years.
6. I will have my boat in the slip by 5:00 PM on June 15, 2019.
7. If I fail to have my boat in the slip by June 15, 2019, I agree to pay a fine of one half my slip fees. If I further fail to have my Boat in the slip or I do not pay the fine by 5:00 PM June 22, 2019, I agree to forfeit my slip and be off the slip waiting list for a period of 3 years.
8. I understand that any requests for extensions of the June 15th deadline due to SIGNIFICANT mechanical or medical reasons must be made IN WRITING to the Fleet Captain by 5:00 PM on June 8, 2019, and that no extensions will be granted beyond July 15, 2019.
9. I agree to have my boat and frog hooks (triangular portion) out of the slip and off Darien Boat Club docks by 5:00 PM November 3, 2019. I also agree to remove any brackets that protrude more than 6" from the dock.
10. I agree to pay a fine of \$100.00 a day, for up to 3 days, if my boat and frog hooks are not removed by 5:00 PM November 6, 2019 after which loss of slip space will occur and membership may be terminated.
11. I agree to notify the Fleet Captain if I have not received my "2020 Slip Holder Agreement" by March 15, 2020. If no such notification is made, the Darien Boat Club will consider the "2020 Slip Holder Agreement" delivered.
12. I agree that the Executive Committee of the Darien Boat Club shall have the final say and ruling on all terms contained in this agreement and the agreement cannot be modified in anyway without the written permission of the Executive Committee.
